Are you interested in an international career? Would you like to learn **about forests and forest management in seven European countries** with a cohort of students coming from all over the world?

Master of Science in European Forestry (MSc EF) is a top-class taught **Erasmus+: Erasmus Mundus Joint Master programme (EMJM)** in the field of sustainable forest management with an emphasis on recent opportunities and challenges in the bioeconomy. It is offered by a Consortium of **seven** leading European universities from **Austria, Finland** (coordinator), **France, Germany, Romania, Spain** and **the Netherlands**. In addition, Associated Partner Universities from **Albania, Brazil, Canada, China, Moldova, Nigeria, South Africa, Ukraine, and US** and several **Associated Industrial/Public/NGO**



Partners worldwide contribute to programme delivery. It is **one of the first EMJM programmes that has been accredited** according to the European approach for quality assurance of the joint programmes.

Our aim is to prepare professionals to tackle **the four Grand Challenges in forestry**: 1) Climate change and the increasing frequency and intensity of natural disturbances, 2) Lack of biomass for the bioeconomy industry and mitigating CO₂ emissions, 3) Declining biodiversity and conversion of forest land to other land uses, and 4) Increasing societal demand for non-market ecosystem services. We will provide students with in-depth knowledge of the “modernised” forest management practices.

The curriculum of the programme is specifically designed to take into consideration the needs of potential employers. Therefore, **our graduates are highly valued** by national and international agencies, governmental bodies, NGOs, research institutions and timber, paper and pulp enterprises.

The programme’s **language of instruction is English**, and it offers great opportunities to learn the local languages and cultures. The MSc European Forestry programme has more than **350 alumni from around 70 different nationalities**. All students graduate with the ability to work in multicultural environments and will possess the latest knowledge of forest management and policy-making in Europe.

Admission requirements

- A bachelor's degree in forestry or other related field with good grades issued by an internationally recognised university.
- Good command of the English language – please see details at the MSc EF website.

Consortium fees

- There are no Consortium fees for students who are citizens of EU/EEA countries or Switzerland.
- 9 000 EUR/year for students who are citizens of non-EU/EEA countries.

EMJM scholarships and Consortium fee waivers

- EMJM scholarships will be available on a competitive basis for EU/EEA and non-EU/EEA students and will include student participation costs (including the Consortium fees and full insurance coverage), and a monthly subsistence allowance for the entire duration of the study programme (1 400 EUR/month for a max. of 24 months).
- The Consortium fee waivers will be available for a number of non-EU/EEA applicants without EMJM scholarships (max. for 24 months) – please see details at the MSc EF website.
